As per directions from the Directorate of Education, Delhi Government and the Hon'ble High Court of Delhi, applying the criteria of neighbourhood, admission shall first be offered to eligible applicants residing within 1 km distance. In case the number of applicants is more than the reserved seats, a draw of lots will be conducted. List of children selected for draw of lots will be put up on the school Notice Board.

The **Draw of Lots** will be conducted on **Friday, 30-04-2021** as per the schedule given below:

10:30 a.m.	:	Class I
11:30 a.m.	:	Pre-Primary (KG)
12.30 p.m.	:	Pre-School (Nursery)

The list of applicants selected for draw of lots will be put up on the website of the school www.rsjms.com.

Kindly bring the self-attested photocopies of the following documents along with the Application Form on the day of submission :-

- (1) **Proof of Date of Birth (Any One):**
 - Birth Certificate of the child under the Births, Deaths and Marriages Certification Act, 1986.
 - Hospital/Auxiliary Nurse and Midwife (ANM) register record.
 - Anganwadi Record.
 - Declaration of the age of the child by the parent or guardian.
- (2) **Proof of Residence: (Any One):**
 - Ration Card/Food Security Card issued in the name of parents (mother/ father having name of the child).
 - Domicile Certificate of child or of his/her parents.
 - Voter I-card of any of the parents.
 - Electricity bill / MTNL telephone bill / Water bill/ Passport in the name of any of the parents or child.
 - Aadhaar Card/UID Card issued in the name of any of the parents.
- (3) **Proof of Income/Caste Certificate (Any One)**
 - Income Certificate issued by a Revenue Officer not below the rank of Tehsildar, or
 - BPL Ration Card (Yellow coloured), or
 - AAY Ration Card (Pink coloured) or
 - Caste Certificate [SC/ST/OBC (Non-Creamy Layer)] of child/parents issued by DC Office.
 - Caste certificate for DG category (SC/ST/OBC)
- (4) Documentary evidence issued by the relevant govt. authority in case of Orphan/Transgender/HIV affected child.
- (5) Medical Certificate from Govt. Hospital, in case of Children with Disabilities (as defined in the RPWD Act 2016).
